

Official Rules

Blizzard of Cash Challenge (Cash Cube)

Thursdays: January 3, 10, 17, 24, 31, 2013

Two winners compete in the cash cube at 1pm, 3pm, 5pm, 7pm, 9pm

Contestants will keep their collected cash winnings.

The player who collects the most money at each drawing time will earn a \$200 Free Play bonus.

Player Extras Club membership and valid photo identification are required to enter contest. Membership is free. Winner must be 18 years or older.

On January 3, 10, 17, 24, and 31, 2013 Player Extra Club members may participate in the Saratoga Casino and Raceway's Blizzard of Cash Challenge promotion by playing any of our video gaming machines with their Player Extras Club card inserted into the card reader. Winners are selected, via the Casino Marketplace Pick Random Player function, at 1pm, 3pm, 5pm, 7pm and 9pm on the promotion dates.

In order to qualify to enter the Cash Cube:

- (a) Participants must have their Player Extras Club Card properly inserted into the card reader at the time of the drawing.
- (b) The player must present a valid photo ID. The name on the ID must match the name on the Player Extras Card in use. Management will verify winner's photo identification.

Once both winners have been determined, each contestant will compete against each other to see who can collect the most cash. The player that arrives to the Player Extras Club first will participate first, collecting as much money as they can in thirty seconds. The second player will then go after and collect as much cash as they can in thirty seconds. There will be a total of \$2,000 in the cube each time a player enters. Each contestant will win the money they collected in the thirty seconds. The contestant that collects the higher amount of cash will win a \$200 Free Play bonus.

Participants are not allowed to trap cash against the walls, floor, or ceiling of the Cash Cube, nor is the participant permitted to reach for cash below knee level. Bills must be inserted into the bill collector box located on the front of the machine. Only bills inserted in the bill collector at the end of the thirty seconds will be awarded. Contestants who are unable to participate may designate a proxy to play for him/her or accept a \$100 cash prize in lieu of entering the cash cube. If a proxy is chosen, the original selected winner receives and is responsible for all winnings and tax liabilities. Club members may only win once per day.

Exclusions:

If the winner is currently banned or excluded from SCR, they will not be eligible to win and a new winner will be drawn. If the winner was previously banned or excluded and their term has expired, the guest must fill out a NY Lottery Gaming Reinstatement Request form. After the guest has been approved for reinstatement, they will receive their prize.

Additional Rules

Prizes are not transferable. All prizes must be claimed within 30 days of the date awarded. All federal, state and local taxes, if any, and all expenses related to the use of the prize are the sole responsibility of the winner.
