

Official Rules

November 3rd Double Jackpot Mania

Win a Jackpot October 6-November 2; Drawing Saturday, November 3, 2012 at 10 pm
10 winners of \$250 Free Slot Play
1 winner of the "Double Jackpot" Grand Prize up to \$5,000

Any Saratoga Casino and Raceway guest who wins a limited voucher jackpot during our promotional period will receive an entry for the Double Jackpot Mania drawings on Saturday, November 3, 2012. All limited vouchers received from a Saratoga Casino and Raceway video gaming machine are clearly indicated with the words "Limited Voucher" printed on the front.

Entry Procedure:

To receive an entry into the drawing, eligible Jackpot winners must visit the Player Extras Club on the drawing date between 9am – 9:45pm. A PEC Rep will print out an entry ticket for each jackpot the player hit during the qualifying period, plus any bonus entries they are entitled to, and place them into the Prize Drum.

Valid photo ID will be required at the Player Extras Club to enter the drawing. At 10pm, 11 winners will be selected out of all entry forms. The first winner selected will win the amount equal to their highest Jackpot hit during the earning period, up to \$5,000. If winner's highest jackpot is \$750 or under, they will be awarded free slot play. If their highest jackpot is over \$750, they will be awarded cash. The next 10 selected will win \$250 Free Play. Winners do not need to be present to win.

The Double Jackpot Mania Grand Prize winner will have their highest promotional period Jackpot matched, up to \$5,000. IE: A player won jackpots of \$800, \$1,460 & \$2,913 during the eligibility period. If selected as the Double Jackpot Mania Grand Prize Winner, they would win an additional \$2,913. Free Play prizes will be rounded up to the nearest \$5. If the player's highest jackpot was more than \$5,000, they would win \$5,000 cash as the Double Jackpot Mania Grand Prize winner.

Diamond & Platinum Bonus:

- Diamond Members will receive a total of 3 entries for each Jackpot they hit during the qualifying period.
- Platinum Members will receive a total of 2 entries for each Jackpot they hit during the qualifying period.

Because players may win more than one limited voucher jackpot in the promotional time period, it is possible for a player to have multiple entries in the drawing and win more than one of the prizes. However, guests may only be eligible for 75 entries prior to entry multiplier per drawing. If the winner is not present, he or she will be contacted the following business day to arrange delivery of the prize. The winner must present valid photo identification to be determined the winner. Management will verify winners' identification.

Exclusions:

If the winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn. If the winner was previously banned or excluded and their term has expired, the guest must fill out a NY Lottery Gaming Reinstatement Request form. After the guest has been approved for reinstatement, they will receive their prize.

Additional Rules

All federal, state and local taxes, if any, and all expenses related to the use of the prize are the sole responsibility of the winner.
