



February Grand Prize Giveaway – Official Rules

Earn entries January 29- February 24, 2012, drawing February 25, 2012
2 winners of \$1,000, \$500 if not present, each hour from 1-10pm (half cash/half free play)
8 winners of \$2,000, \$1,000 if not present, at 11pm
1 winner of \$10,000 cash at 12am

Player Extras Club membership and valid photo ID are required to enter contest. Membership is free. Winner must be 18 years or older.

Entries

All Player Extras Club members are eligible to earn, at no point reduction, one (1) drawing entry per \$50 of carded play on slot machines or \$150 of carded play on Electronic Table Games from **January 29- February 24, 2012**. Club members must be playing with their Player Extras Club card properly inserted into the gaming machines to earn entries. Entries earned will be automatically entered into the drawing.

Grand Prize Drawing

All entries earned by the end of the gaming day on **February 24** will be eligible for the grand prize drawings. On the day of the grand prize, Club members must activate their entries by properly inserting their Club card into any video gaming machine and recording play on the Club card. Entries must be activated approximately 30 minutes prior to the next drawing time in order to be eligible. Once entries are activated they are eligible for all future drawings on **February 25**. No entries will be activated after 11:30pm for the midnight drawing.

Every hour, from 1 – 10pm, (2) two winners will win \$1,000 (\$500 cash, \$500 Free Play). If the winners are not present and do not visit the Player Extras Club within 10 minutes from when their name was announced, they will win \$500 (\$250 cash, \$250 Free Play).

At 11pm, we'll select and announce eight (8) winners of \$2,000 cash. If the winners are not present and do not visit the Player Extras Club within 10 minutes from when their name was announced, they will win \$1,000 cash.

At 12am, we will select and announce (1) one winner. The name selected will win \$10,000 cash. This winner does not have to be present to win and there is no bonus if present.

All winners must produce valid photo identification to be determined a winner. Management will verify winners' identification and Club membership.
