Player Extras Club membership and valid photo identification are required to enter contest. Membership is free. Winner must be 18 years or older.

All Player Extras Club members may participate in the Mystery 1000 Kiosk Promotion on Thursday, November 22, 2012.

To participate, guests must log into their account on any kiosk on the day of the promotion. 1,000 random guests accounts will be loaded with \$100 or \$250 in Free Play. Player must check the "Redeem Offers" screen to see if they are a winner.

Free Play prizes will automatically print out of the kiosk.

Exclusions:

If the winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn. If the winner was previously banned or excluded and their term has expired, the guest must fill out a NY Lottery Gaming Reinstatement Request form.
