## Official Rules

### \$10,000 Plinko

Thursdays: February 7, 14, 21, 28, 2013

One winner selected every hour 1pm-8pm to play Plinko

Player Extras Club membership required to enter contest. Membership is free. Winner must be 18 years or older.

Player Extras Club members playing with their Club card on any video gaming machine at the drawing times are eligible to win a chance to play Plinko. One (1) winner will be randomly selected every hour 1pm-8pm to play Plinko.

At each drawing time, a PEC representative will select one winner using the Casino Marketplace "Pick Random Players" Function. The winner's name will be announced over the loud speaker and they will be instructed to report to the Club with valid photo ID within 5 minutes. If the winner does not report to the Club within 5 minutes to claim their prize, another winner will be selected.

#### \$10,000 Plinko Puck

Each contestant will initially be asked to select nine (9) envelopes out of the prize drum (containing 150 envelopes) located next to the Plinko board at the PEC. A representative of the Player Extras Club or Marketing Department will then place the envelopes in every other slot at the bottom of the Plinko board. The contestant will then be given a special \$10,000 Plinko puck which they must drop from the top of the board. Once dropped, the envelope and puck will be placed to the side and will be the last envelope opened once all pucks have been dropped.

#### Prizes

Once the \$10,000 puck has been dropped, the contestant will be given the following number of black pucks:

- Gold = 3 pucks
- Platinum = 4 pucks
- Diamond = 5 pucks

The contestant will drop the pucks one at a time from the top of the board. When a puck lands in a slot at the bottom, the puck will be removed and the envelope will be opened to reveal the prize. Each envelope will have prizes ranging from \$50 up to \$1,000. If a puck lands in a slot without an envelope (because a puck already landed in that slot), it will be considered a losing drop. This process will be repeated until all pucks have been dropped. If one of the envelopes from this portion of the game contains the \$10,000 prize it will be considered a non-winner, because the \$10,000 puck did not land in that slot.

The first \$500 in prizes will be awarded in Free Slot Play. Prize amounts over \$500 will be given in cash. (i.e.: if a guest's winnings total \$600, they will be given \$500 Free Play and \$100 cash.)

Once all pucks have been dropped, the PEC or Marketing representative will open the envelope associated with the \$10,000 puck. If the \$10,000 prize is inside the envelope that the \$10,000 puck landed on, the contestant will win \$10,000 cash. If it is any other prize, they will not win a prize for this element of the game. At the conclusion of each contest, a PEC rep will return all envelopes to the prize drum so there will be the same 150 envelopes for the next contestant.

Must be present to win. The winners must visit the Club within 5 minutes to participate. If a winner reports to the Player Extras Club within 5 minutes, but does not have valid photo ID, they will be given 30 days from the drawing date to claim their prize with proper photo ID. Management will verify winners' identification and Club membership.

#### Exclusions:

If the winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn.

#### Additional Rules

Prizes are not transferable. All prizes must be claimed within 30 days of the date awarded. All federal, state and local taxes, if any, and all expenses related to the use of the prize are the sole responsibility of the winner. By participating, contest entrant agrees to the official contest rules and, where legal, the use of winner's name and/or likeness for advertising and publicity purposes without compensation.
