



Official Rules

October Plinko Promotion

Thursdays: October 3, 10, 17, 24, and 31, 2013

One (1) winner selected at random times between 12pm-10pm to play Plinko.
Six winners per day.

Player Extras Club membership required to enter contest. Membership is free. Winner must be 18 years or older.

Entries:

Player Extras Club members playing with their Club card on any video gaming machine at the drawing times are eligible to win a chance to play Plinko.

One (1) winner will be randomly selected at random times between 12pm and 10pm. There will be six (6) winners per day.

At each drawing time, a PEC representative will select one winner using the Casino Market Place "Pick Random Players" Function. The winner's name will be announced over the loud speaker and they will be instructed to report to the Club with valid photo ID within 5 minutes. Must be present to win. If the winner does not report to the Club within 5 minutes to play Plinko, we will select another winner. If a winner reports to the Player Extras Club within 5 minutes, but does not have valid photo ID, they will be given 30 days from the drawing date to claim their prize with proper photo ID. Management will verify winners' identification and Club membership.

Plinko:

Every slot will be designated with a Free Play prize amount ranging from \$50-\$200. The contestant will drop a puck on the board and will land into a prize slot. They will receive the prize that the slot is designated with. The puck will be removed from the board allowing the contestant's remaining pucks to land in the previous prize slot.

Below is the set up of prize amounts for each slot.

Winners will be given the following number of pucks based on current club status:

- Gold = 3 pucks
- Platinum = 4 pucks
- Diamond = 5 pucks

One at a time, a player will drop the pucks from the top of the board. When a puck lands in a slot at the bottom, the puck will be removed and the correct prize amount will be documented. This process will be repeated until all pucks have been dropped. A Player Extras Club representative or member of Marketing will then add the totals of Free Play prizes.

The first \$250 in prizes will be awarded in Free Slot Play. Any remaining prize in addition to the \$250 Free Slot Play will be awarded in cash.

Exclusions:

If the Winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn.

Additional Rules

Prizes are not transferable. All prizes must be claimed within 30 days of the date awarded. All federal, state and local taxes, if any, are the sole responsibility of the winner.
