



Official Rules

\$100,000 Monster Cash Video Scratch & Win

One winner selected every hour from 12pm-9pm, via Hot Seat, for a chance to win up to \$100,000 in the Monster Cash Drawings

Player Extras Club membership and valid photo ID are required to enter contest. Membership is free. Winner must be 18 years or older.

Entries:

From 12pm-9pm, Player Extras Club members playing with their Club card inserted into any video gaming machine at the time of the drawing are eligible to win.

Monster Cash Drawings

One (1) winner will be selected every hour from 12pm-9pm, via CMP's Pick Random Player Function, to win up to \$100,000 on our Monster Cash video scratch & win tablet. There will be 10 total winners each day.

Once the winner is drawn and their gaming location has been determined, the Prize Patrol will bring the "Monster Cash Scratch n Win" hand-held tablet game to the winner's gaming position. If the original hot seat winner has left their gaming location, the guest sitting on the game closest to the right of the original winner's machine and playing with their Player Extras Club card will be the new winner and will have the chance to play the game.

To play the game, the winner will touch 6 of the 36 boxes on the screen to see how many winning Ghost symbols they can reveal.

- ***If the contestant finds all 6 winning ghosts symbols, the winner will receive \$100,000 (paid out by a promotional company upon official verification)
- If the contestant finds 5 winning ghosts symbols the winner will receive \$750.
- If the contestant finds 4 winning ghosts symbols the winner will receive \$500.
