

# **Official Rules**

# \$17,500 Holiday Wish List Promotion sponsored by Spielo

Player Extras Club membership and valid photo ID are required to enter contest. Membership is free. Winner must be 18 years or older.

#### **Entries**

All Player Extras Club members are eligible to earn, at no point reduction, one (1) Wish List drawing entry per every 25 base points earned December 1-17, 2012. Club members must be playing with their Player Extras Club card properly inserted into the gaming machines to earn points. A point is earned for every \$50 of carded play on Slots and \$150 of carded play on ETGs. Players will earn 2x entries when playing on Spielo games.

## **Entry Ticket Deposit Period**

All participating players who have earned at least 25 base points between December 1-17, 2012 are eligible to pick up their entry tickets at the Player Extras Club December 18-21 2012. Players will receive 1 entry ticket (in the form of a boca) for every 25 base points earned December 1-17, 2012. *IE: If player has earned 208 base points, player would receive 8 entry tickets.* 

Players will then be invited to deposit their entry tickets into the box or boxes representing the prize(s) of their choice. Players may distribute their entry tickets however they choose. They may deposit all tickets in 1 box, or 1 ticket in every box, or any other breakdown of their choosing.

Everyone who participates by claiming their entry tickets from Dec 18-21 will receive a bounceback offer for \$10 Spielo Free Slot Play which will be valid Dec 22-31, 2012.

#### **Exclusions:**

If the winner is currently banned or excluded from SCR, they will not be eligible to win and a new winner will be drawn.
