## Official Rules

### You Play, We Pay

Sunday, January 13 and 27, 2013

Earn 15-29 points and receive \$10 FP in the kiosk

Earn 30-49 points and receive \$20 FP in the kiosk

Earn 50+ points and receive \$40 FP in the kiosk

Player Extras Club membership and valid photo identification are required to enter contest. Membership is free. Winner must be 18 years or older.

#### Entries

All Player Extras Club members are eligible to earn, at no point reduction, one (1) entry per \$50 of carded play on slot machines or \$150 of carded play on Electronic Table Games from 9:00am-4:00am on each gaming day of the promotion date (Sunday, January 13 and 27, 2013.) Club members must be playing with their Player Extras Club card properly inserted into the gaming machines to earn entries. Entries from January 13, 2013 will not carry over to January 27, 2013.

Eligible players must log into their kiosk account on the date of the promotion to receive their "You Play, We Pay" bonus free play before the end of each gaming day. The amount of Free Play will be based on the number of entries earned on each gaming day of the promotion.
