

## **Official Rules**

# \$100,000 Zoom Ball Promotion

Drawings: Thursdays, December 6, 13, 20 and 27. Saturday, December 15 and 22.

Two (2) winners, via hot seat, are selected to play Zoom Ball every hour from 1 pm-10pm

## **Entries:**

Player Extras Club members playing with their Club card on any video gaming machine at the drawing times are eligible to win a chance to play Zoom Ball. Two (2) winners will be randomly selected every hour from 1:00pm – 10:00pm.

On Thursdays, December 6, 13, 20, 27 and Saturdays, December 15 and 22, the first drawing will be open to Diamond/Platinum/Gold players and the second drawing will only be open to Diamond/Platinum players.

At each drawing time, a PEC representative will select two winners using the Casino Market Place "Pick Random Players" Function. The winners' names will be announced over the loud speaker and they will be instructed to report to the Club with valid photo ID within 5 minutes. If the winner does not report to the Club within 5 minutes to claim their prize, another winner will be selected to play Zoom Ball.

## **Playing Zoom Ball:**

In the order they arrive at the Club, each contestant will have one (1) attempt to play. Contestants will press the start button to activate the game device blower. As the Zoom Balls mix together in the game device, six (6) balls will fill the Zoom Zone tube. Only the balls that settle in the Zoom Zone without interference from any person or object will be eligible for play.

There are 50 balls in the game device. There are ten (10) winning balls that will be marked with the color red and forty (40) are white. The amount of winning red colored balls that fill the Zoom Zone will determine the prize winnings:

#### **Zoom Ball Prizes:**

0= \$50 Free Slot Play

1 = \$100 Free Slot Play

2 = \$250 Free Slot Play

3 = \$500 Cash

4 = \$1000 Cash

5 = \$10,000 Cash (paid out by promotional company)

6 = \$100,000 Cash (paid out by promotional company)

Players may only win once per day. The names of the winners will be announced over the PA system throughout the gaming facility. Reporting to the Player Extras Club within 5 minutes from when the winner's name is announced is considered present for that hour's drawing. All winners must produce valid photo ID to be determined a winner. Management will verify winners' identification and Club membership. If a Winner reports to the PEC within 5 minutes, but does not have valid photo ID, they may NOT participate in the promotion. A new winner will be selected.

Each insured prize (\$100,000 and \$10,000) may only be won once over the course of the month. If one of the insured prizes is hit, the \$100,000 and \$10,000 prices will be lowered to \$2,500 for the remainder of the month.

If a player wins an insured prize of \$100,000 or \$10,000 they must fill out a Winner's Affidavit & Release. Payment will be issued upon confirmation from the promotional company.

#### **Exclusions:**

If the winner is currently banned or excluded from Saratoga Casino and Raceway, they will not be eligible to win and a new winner will be drawn. If the winner was previously banned or excluded and their term has expired, the guest must fill out a NY Lottery Gaming Reinstatement Request form. After the guest has been approved for reinstatement, they will receive their prize.

### **Additional Rules**

Prizes are not transferable. All prizes must be claimed within 30 days of the date awarded. All federal, state and local taxes, if any, and all expenses related to the use of the prize are the sole responsibility of the winner. By participating, contest entrant agrees to the
