## **Entries**

Ten (10) contestants will be randomly picked from online registration. You can also register at Vapor between 7-8pm that night. Ten (10) Singers will be randomly picked in Vapor for their chance to impress the judges between 8:30-11pm. All registration and check in must be complete by 8pm with no exceptions. Song selection must be a song that has been or is currently a Top 40 Billboard Country Hit. \*No one who is currently signed with a label will be allowed to compete.

## Contest

The top 5 singers of each contest night will be invited back for Country Idol Karaoke Finals on June 20<sup>th</sup>, 2013.

The winner of the finals will receive \$5,000 cash.

Winners are determined by the judgeøs decision. Judgesø decisions are final. Guest Judges will be brought in each month as well as for Country Karaoke Finals on June 20<sup>th</sup>, 2013.
