Attached is the 2022 Stall Application. Complete the information for all horses you wish to stable at SCH, review the conditions on page two of the application, sign and return to me via the Stable Gate. You can also scan and email your completed application to stalls@saratogacasino.com. Stall applications are due on January 31, 2022.

Important:

1. If your stall application is approved, you will be assigned a specific number of stalls in a specific barn. If you acquire additional horses they must be approved by me. Do not put horses in stalls that have not been assigned to you.
2. The number of tack and feed stalls is limited. Trainers with six or fewer horses will be assigned one tack and one feed room.
3. Stalls assigned for horses may not be used for storage.
4. If you will no longer be stabling horses on the backstretch all stalls, tack and feed areas must be cleaned out upon departure. Any items left behind will be considered abandoned property if not claimed by the departing trainer within 30 days, and will be discarded.

POSITIVELY NO HORSES WILL BE ACCEPTED UNLESS STALL RESERVATIONS ARE CONFIRMED. Stalls will not be held after expected date unless change is confirmed. No substitutions or additions to the above named horses will be permitted unless confirmed by The Racing Secretary prior to shipping date. Your cooperation in advising us immediately of horses dropped from training or not to be raced here will be greatly appreciated.

COGGINS TESTS AND STABLE ROSTERS MUST BE FILED WITH THE RACING SECRETARY UPON ARRIVAL. Signer of the stable roster will be responsible for the conduct of grooms. SARATOGA CASINO HOTEL RESERVES THE RIGHT TO DECLINE SPACE TO OWNERS AND TRAINERS, AND UPON 48 HOURS NOTICE OWNERS AND TRAINERS AGREE TO VACATE ASSIGNED STABLES. Carefully read the conditions on the reverse of this application where you will find space provided for signature.

Important – Please Read Carefully

CONDITIONS

1. "All risks, loss, injury, damage or destruction to person, property and/or horses of the licensee by fire, theft, accident or otherwise are assumed in full by the licensee, whether caused by active or passive negligence of the licensor, the condition of the premises or any other reason or cause whatsoever." The undersigned hereby agrees to indemnify and hold harmless Saratoga Casino Hotel and its officers, employees and agents from and against any injury, loss, damage, liability or cost, including attorneys' fees, suffered by Saratoga Casino Hotel, its officers or employees or by any other person or persons whatsoever by reason of anything or matter done or failed to be done by the undersigned, his/her agents and employees or by reason of the condition of anything done by any horse or equipment belonging to or in the custody of the undersigned, his/her agents or employees, whether any such damage occurs on the aforesaid premises or elsewhere.

2. The undersigned recognizes that Saratoga Casino Hotel has the exclusive and inherent right, in the exercise of its own discretion, to revoke and cancel at any time this limited and conditional occupancy and use of all or any of its stall and stable facilities and therefore agrees to and shall remove all or any one or more of his horses, and to vacate such stall spaces within a maximum of 48 hours of any such notice to their removal. In the event of failure of the undersigned to vacate upon notice herein before provided, he/she does hereby unconditionally waive any and all prevailing and applicable statutory procedures to the contrary. In the event of his/her failure to enter or race any horses or to timely remove any one or all of the horses, he/she does hereby unconditionally further authorize and empower Saratoga Casino Hotel to remove and place such horses in any private or public stables, farms or the like which may then be available, all at the undersigned's own direct expense and he/she does hereby further hold Saratoga Casino Hotel and its officers, agents and representatives harmless and free from any and all obligations, liability and expense whatsoever including all disbursements and legal fees in connection with any of the foregoing.

3. **Saratoga Casino Hotel, in the exercise of its own discretion, has the right to reject any entry in a SCH overnight event and return fees paid for any early/late closer sponsored by SCH.**

4. Coggins tests for all horses stabled on the grounds must be on file in the Race Office. Stable Rosters and claiming authorizations and registration certificates for horses entered in claiming races must be on file in the Race Office.

5. In the best interest of racing, Saratoga Casino Hotel reserves the right to refuse admittance to or eject anyone, considered undesirable.

6. Smoking in horse stalls, feed rooms and under the shedrow is strictly prohibited.

7. Any stalls assigned as a "horse stall" may not be locked at any time.

8. No oil or gas-burning lanterns, heating appliances, open pit fires or cooking grills are allowed in the stable area.

9. No flammable material, such as cleaning fluids and solvents shall be used in the stable area.

10. All electrical appliances used in the stable area must be in safe working condition and, when in use, must be located at a safe distance from walls, beds and other furnishings, and shall not be left unattended when in operation.

11. No hay or straw in a loose form may be stored under the sheds or outside of feed rooms.

12. The alleyways in front of stalls must be kept free of debris and open at all times to give easy access to each stall in case of fire.

13. All visitors permitted in the stable area are required to sign in at the stable gate and be escorted by a licensee.

14. All trainers are required to have a certificate for Workers Compensation Insurance on file with the New York State Gaming Commission (NYSGC Rule #4101.31).

15. Rules and regulations of the New York State Gaming Commission shall govern the meet.

16. **Horses stabled at SCH during a race meet must race at this facility. The exceptions are:**

1. **Early and Late Closers (paid events)**

2. **Sire Stakes**

3. **Horse is of superior ability and too competitive for the local horse colony.**

4. **Any legitimate reason which is acceptable to the Director of Racing.**

17. **Trainers stabled at SCH are required to make at least 75% of their overnight starts at SCH from March 1st to December 15th or they may be subject to immediate forfeiture of stalls.**

18. **Trainers stabled at SCH who also have horses on farms, said horses are still required to race at SCH unless given direct permission by the Race Secretary.**

19. **Trainers stabled at SCH who have permanent residence in New York State will be required to race here for the entirety of the meet.**

20. NYSGC Rule #4118.4 will be strictly enforced (re: purse schedule).

21. The undersigned agrees that they will remit to Saratoga Casino Hotel within ten days of receipt, payment for any repairs to the barns and/or stalls due to neglect or abuse.

22. Further, any vacated stall not found in the condition it was in when assigned, the assignee will be assessed a fee to cover the cost of repairs.

23. **All stalls, tack and feed areas must be cleaned out upon departure. Any items left behind shall be considered abandoned property if not claimed by the departing trainer within 30 days.**

24. Violation of any of the above conditions will result in immediate notice to vacate.

25. All horses stabled at SCH must use track required bedding.
